

We are pleased to present the 2015 InterPride Annual Report. As with many organizations, the past twelve months have seen both challenges and major achievements for InterPride.

The work of InterPride is driven by its many Committees and Regional Directors, all of which are vital to the organization's continued success. We encourage you to read this report to learn more about their work. Some of the highlights include, the CSIC Committee, working to revise and clarify many of the rules and procedures around our Conferences, Member Services working to maintain our membership. and Communications pro-actively reacting to events affecting our members across the globe through letters of support and media releases. We are also looking forward to a new draft of the Pride Radar, and its insights into the Pride around the globe.

The Solidarity Committee worked to reinvent our grant making process from the ground up, setting the stage for 2015, our most successful year yet. We were able to make 5 grants that impact Prides in hostiles climates globally. Thanks to Human Rights Campaign (HRC), we already have the largest single donation to the Solidarity Fund to date to use this coming year. We look forward to a long and mutually beneficial relationship with HRC — along with all of our affiliate members.

One focus of the past year has been to foster a closer working relationship with our Pride Partners — The European Pride Organisers Association (EPOA) and Fierté Canada Pride (FCP). To this end, Sue attended and addressed the FCP Conference in the early part of 2015 and Brett instigated high level talks with the then EPOA President, Hans De Meyer and the newly elected EPOA President, Kristine Garina during a visit to the south of France. Together we will continue these conversations at this year's conference to ensure we maintain a close and amicable working environment between the three organizations.

As we move closer to our 2017 WorldPride in Madrid, Spain, work will start in earnest with the host organization to ensure InterPride provides AEGAL with all the necessary support they require to continue the successful legacy created by Toronto of our WorldPride brand. We will ensure that our WorldPride Committee are armed with all the support in order to do this effectively.

This year's AGM and World Conference will see some fairly major Bylaw and Standing Rule changes proposed for InterPride (including a new way to vote from our newly formed Governance Committee and the re-introduction of the Trans* Vice President Board position), voting on the 2017 conference, and WorldPride 2019 and the release of Pride Radar. Suffice to say it will be an exciting time for InterPride — both at this conference and for the years ahead.

We have immensely enjoyed the opportunity to work together as your Co-Presidents and look forward to seeing you in Las Vegas and the 2015 InterPride AGM and World Conference!

We'd also like to thank Southern Nevada Association of Pride, Inc. (a.k.a. Vegas Pride) and CAPI for their hard work to bring us this conference.

Executive Committee Reports

VICE PRESIDENTS' REPORTS

Cain Williamson Vice President Operations

Regional Conference Participation:

I attended the Fierte Canada Pride Conference. It was a successful event and offered good networking and capacity building opportunities. Additionally, I was able to assist the Co-President in attendance with facilitating a discussion on the Pride Radar which was quite well received.

I also attended the Pride of the Southeast annual regional conference. I have supported this conference by connecting the organizers with the HRC national staff for the purpose of planning session content. As a result, there were two sessions at the POSE confernce in which HRC participated. This is a result of the goal set by membership at the 2013 Annual General Meeting to have InterPride develop a stronger relationship with HRC. Additionally, I updated the assembled participants on the on the status of the InterPride and its programs.

Regional Director Support:

I responded to several requests from regional directors for information about membership lists for their respective regions - providing those lists which enable the RD to communicate relevant information to members. I also followed up with RDs on requests that have been made by members or potential members to ensure that responses were made.

Membership Development:

I met and recruited as members the leadership of Costa Rica Pride. With the strong support of Emilio Aguilera and Luis Conti, VP Ops and RD respectively for the region in which Costa Rica is located. Not only has Costa Rica Pride joined a members, but they received a scholarship to attend the AGM. This furthers the goal of expanding membership numbers as well as the diversity of the membership.

Committee Participation

Additionally, I actively participated in the Human Rights and Solidarity Committees. Both Committees had very successful years which are described in their respective sections of the annual report.

Dallas Barnes Vice President Operations

Committee Listing:

I serve as Co-Chair for the Solidarity Committee with Doug Kerr (Pride Toronto), and am a member of the Communications Committee as the Twitter handler.

Report:

As this was my inaugural year as Vice President Operations, this year allowed me to really gain an understanding of the inner-workings of InterPride as well as an understanding of the communities that we serve.

During the 2014 AGM in Pittsburgh where I was first elected, I was involved with improving a long-standing concern with the InterPride organization. Our lack of commitment to the Trans community, and the lack of representation of non-binary folks in our membership. Myself, along with the InterPride board were dedicated to introducing a VP Operations position for Trans-identified folks and the final vote was held at the final plenary in Pittsburgh. It did not pass, and I believe this is where my belief in our entire community took the lead in my tenure as VP Ops.

This year my focus has been doing my part to make ourselves (InterPride) as representative of the Global LGBTTIQQ2S as possible, taking into consideration our limitations as a growing, non-profit organization.

In addition to my work as Co-Chair of the Solidarity Committee, I have also headed up a Trans Bylaw group determined to get the VP Ops, Trans-identified position passed.

I have had a few challenges getting in contact with my Regions. Region 7 (Canada) and I have consistent communication, and I have attended two Pride's from this Region, volunteering for both (Calgary and Vancouver). My other regions have been reached out to, but I have received no response from.

Goals for the Coming Year:

Goal: To advocate for a VP Operations, Trans-identified Responsibility: To continue to work with our committee to ensure that the final vote passes. Active search for a good candidate for the position. Measure: The position passes the final vote Status: Advocating for the first round of votes.

Since the AGM I have sent out emails to member organizations I am in charge of as VP in order to encourage them to be more active with InterPride and to share information about what's going on on their countries, cities etc. Particularly in Spain I held meetings with the Spanish prides in order to encourage them to join EPOA and InterPride.

As VP Operations I am in regular communications with the regions I am in charge of.

During the International Fair of tourism in Madrid I made a presentation about InterPride, its mission, vision and structure. I created this presentation in 2013 and have used since.

In the last three years InterPride has been trying to increase membership South America and Central America.

I am very pleased to have contributed to this in collaboration with Cain Williamson. This year Costa Rica Pride has joined as a member if InterPride and I hope this to be the first one of many from the region..

We are currently speaking with Chile and Buenos Aires Pride in order to enroll them as well.

Regarding my duties as an executive committee member I have regularly attended InterPride board calls and actively participated actively on them.

This year also I had the honor of being CSIC Co Chair.

I really enjoyed my two terms as VO Operations. I want to give all my gratitude to all my fellow board members for their support.

FINANCE REPORT

The anticipated Income and Expenses for the last 4 months of the year, of which our AGM is held, is projected as indicated in the approved budget for 2015. See Budget vs. Actual (year to date 8/31/15) in the following pages.

For accounting proposes and ease of operations, Budget items for income and expense were created and approved for working Committees. These include: Finance, Human Rights, WorldPride, Fund Development, CSIC/Conference, and Communications. Pride Radar, a program of InterPride, also has a budget line for 2015.

Scholarship and Solidarity budget items are classified as restricted funds and expenses as indicated.

There have been no line item changes to the budget by the Board for 2015. It is anticipated that each Committee will stay within its budget for the year.

InterPride holds two checking accounts (Bank of America and First Commonwealth Bank). InterPride also has two Investment accounts; a money Market Account with First Commonwealth Bank and an Investment Account with Calvert Investments. As the Balance Sheet indicates (Calvert Investments) has a balance of \$163,156.74.

The tax returns and filing for 2014 was submitted and filed by InterPride's CPA, Julie Siska.

The proposed budget for 2015 will be produced at the last Finance Meeting of the year at the AGM. This proposes budget will be presented to the membership at the schedule Plenary for approval. A call for budget items has been sent to committee chairs to be discussing at this Finance meeting. It is anticipated that the proposed budget for 2016 will not deviate much from this past 2015 budget

Report:

Unfortunately, this July the Chair of the Communications committee had to step down for personal reasons. Since this time the role of Chair has been taken over by Brice Field.

Over the course of the year the Communications Committee was able to send out three newsletters. They were distributed to the membership in the months of March, September and October. Three letters of support were created. One in support of Mozaika, the organizers of this year's EuroPride, another in support of the Rainbow Action and Korea Queer Culture Festival organizing committee and the last in support of the Verona Pride organizing committee. Two media releases were created and distributed. The first condemning the violent attacks that occurred during Pride Parade in Jerusalem, where participants were stabbed by a religious extremist as the procession marched peacefully through the streets of the holy city. The second media release was in regards to the 2015 Solidarity grant recipients. This work of the Communications Committee is vital in assisting the Co-Presidents (the mandated authors of all outward official correspondence for InterPride) to disseminate the organization's responses to world events of importance and interest in a timely and accurate manner.

InterPride's social media presence consists of a Facebook, Twitter and Instagram account. The Facebook account as of September 15th had 7180 likes, Twitter had 4143 followers and our Instagram account had 191 followers. Increasing our social media reach and improving overall engagement has been, once again, discussed in the Communications Committee meetings. One way that is being investigated is the creation of original content. The creation and distribution of original content will be a continued conversation taking place at this year's AGM & World Conference.

As the year came to a close the Communications Committee met to review, edit and assemble the 2015 InterPride Annual Report. This year the Communications Committee took on the task of editing submissions to the annual report. The intent of the editing processes was to insure that the annual report highlighted the work of the organization in a professional manner. Edits to submissions were only made in an effort to improve grammar, spelling and consistent formatting. The intent of the process was not to change the spirit of any submissions.

Report:

The tasks of the Fund Development Committee is always a work in progress. We are happy to say that in 2014-2015 we have had many more conversations and opened dialogue with many companies and organizations, and while not all of those have resulted in funds being delivered to the organization, but we have gotten our name, our brand and our potential impact to those who have looked and found InterPride to be an organization of much significance in the LGBTI community both in the United States, North America and Globally.

We are still in talks with some potential funding sources at the time of this report and hope that we will have some more information to share at the Annual General Meeting in Las Vegas, Nevada, USA the week of October 14-18th, 2015.

The committee would like to acknowledge Sherri Rase, Vice President of Member Services has been especially helpful in working with potential partners through the lens of the Member Services Committee that she Co-Chairs. This cross-committee work is close to developing a potential partnership that will not only be a possible revenue source, but also a benefit for our members. Sherri is working with a filmmaker and working with their production company about screening opportunities. This kind of work is a "win-win opportunity" and we should look at this as a model for other committees to follow where applicable.

Additionally the committee would like to recognize Region 12 Director, Stefan Baier, who is the longest serving member of this committee and has been helpful each year trying to have our Committee apply for funding through his employment's "LUSH Fund" — With new rules and application process in place for 2015, Stefan once again has been fantastic in getting this information to the Chair of this committee and will be reviewed at the in-person meeting at the AGM in Las Vegas.

Marsha H. Levine, Founder of InterPride and Parade Manager from San Francisco Pride is working on establishing a dialogue with Hard Rock Café for future fundraising opportunities. Former InterPride Co-President Gary Van Horn, Co-President Sue Doster and Treasurer Linda DeMarco have been in contact with American Eagle Clothing as well about funding sources.

The committee is presently working on a Sponsorship Package that will be appealing to a wider variety of funders and partners globally that taps into the very large network of local communities that InterPride has through its member organizations. This is very important work and is taking longer than we would have liked, but the work continues and is being done slowly to ensure that we don't rush something that won't have the maximum impact.



The Chair of this Committee, Paul Sanders has also updated the InterPride store at http://interpride.spreadshirt.com/. The site now has almost 50 different items from tote bags to glassware to tablet/cellphone cases as well as shirts and sweatshirts in sizes up to 5XL so that there is something available for even greater amounts of members. Prices have also been reduced where they could be to also allow for more of our branding to be out in the world while hopefully selling more this year due to the lower prices. In the past years the store has not been very successful in terms of raising funds. The store also have this year's theme logo in American English, UK English, French and Spanish available on products. Also presently NERP — Northeast Regional Prides (Region 6) has their logo tee-shirt available for purchase, with other regions and events coming soon.

Finally working with the Communications Committee we have featured "Amazon Smile" through our newsletters and Facebook page throughout the year. Amazon Smile is the philanthropic arm of online retail giant, Amazon. Amazon Smile donates .5 % of every purchase before taxes to designated charities. The prices are the same on Smile as on the standard Amazon website. InterPride is one of the charities you can select from over 1 million of them. 

Report:

The Methods & Standards (M&S) Committee meets via webinar and teleconference at 6:00pm (EST) on the second Sunday of each month. To date, the M&S Committee has been working on the following:

- Standing Rule 09.02, Section 1. (Reference pages 58-59 of the Methods and Standards Guide.) Standing Rule 09.02 pertains to the Annual Goals Process. Section 1- Membership Dialogue does not outline specifics on how annual goals should be collected from the membership. Also, the current process does not allow for the InterPride Board of Directors to ascertain if suggested goals are from the individuals or member organizations. The M&S Committee formalized the process by creating a form that will be submitted by member organizations, given that InterPride is an organization of organizations. The form will allow the submitting organization to (1) Identify the goal; (2) Suggest a metric to measure the goal; (3) Suggest the committee(s) for goal oversight; (4) Allow for more than one member organization to note support for the goal. This Standing Rule change was presented to the InterPride Board of Directors at the 2015 Mid-Year Board Meeting and passed. The Methods and Standards Guide has been updated to reflect the change. The Co-Presidents disseminate all forms prior to each Annual General Meeting and World Conference.
- Article IX, Section 4. (Reference pages 13-14 of the Methods and Standards Guide.) Article IX pertains to the Annual General Meeting and World Conference. Section 4- Voting, as it stands, requires member organizations to be present to



cast its vote at the Annual General Meeting and World Conference. Feedback received from the last conference survey expressed frustration that InterPride bylaws did not provide a process for member organizations to cast a vote if the member attended the AGM & World Conference but had to leave early. This topic was discussed at the 2015 Mid-Year by the Board of Directors; however, no action was taken because proposed bylaw amendments are voted upon by the InterPride membership. It is the understanding of the M&S Committee Co-Chairs that someone will submit a bylaw amendment on this matter at the 2015 AGM & World Conference.

- Article V, Section 7. (Reference pages 7-8 of the Methods and Standards Guide.) Section 7- Vice President of Operations, Duties and Responsibilities, as it stands, does not require any of the Vice Presidents to Co-Chair a committee. It has been an unofficial standard that each Vice President do so; however, the M&S Committee will submit a bylaw amendment at the 2015 Annual General Meeting and World Conference that amends item F of Article V, Section 7 so that each Vice President is required to Co-Chair a committee and actively serve on at least one other committee. (Please note that this update has not changed since the 2015 Mid-Year Report.)
- Vice President of Operations, Trans Identified. James Hermansen-Parker, on behalf of the M&S Committee, drafted a bylaw amendment based on past amendments. The amendment seeks to amend Article V- The Executive Committee. Dallas Barnes has chaired a subcommittee to work on a promotion/education plan for this proposed bylaw amendment. Two calls have been held since the 2015 Mid-Year Board meeting. A final call of the subcommittee is scheduled for 10/3/15.
- Article V, Section 11. It was noted in the 2015 Mid-Year Report that the M&S
 Committee was slated to discuss Article V, Section 11- Elections- Nominations to
 Office and that an update would be provided in the Annual Report. Please note this
 item was transferred to the Governance Committee.

Report:

Currently, injustice and inequality exist around the world for many LGBTI people and communities. In much of the world, accessing funding support for even the smallest public actions and events is an enormous challenge. InterPride's Solidarity Fund is designed to address this gap.

The mission of InterPride's Solidarity Committee is to distribute the voluntarily collected funds from our membership and sponsors, to organizations that are helping to create change and promote a better understanding of the LGBTI communities. The committee does this by awarding grants to community-based events around the world, with a focus on places where public LGBTQ events face challenges and hostility.

Since the fund was launched in 2013, grants have been awarded to help produce an LGBTI film festival in Macedonia, a mass LGBTI wedding in the Philippines, and Pride gatherings in Uganda and The Bahamas.

2015 Solidarity Fund: Funding Criteria and Process:

This year the Solidarity Fund developed the following granting criteria:

- Projects must take place in the 2015 calendar year.
- Projects in the global south and east (outside the USA/Canada, western Europe and Australia/NZ) would be a priority for the fund.
- Projects must support specific local events and activities that support LGBTI communities, including Pride events.
- Projects must be time-limited, such as political marches, parades, community gatherings, film festivals, special events, and celebrations.
- Project funding is allowed to cover costs such as staff time, advertising, space or equipment rentals, registration fees, purchase of materials.

What we will not fund:

- Individuals not connected to an organization
- Ongoing operating costs for organizations
- Ongoing program costs
- Capacity building or training
- Paying off organizational debt

These criteria were developed by the leadership of the Solidarity Fund Committee and reviewed by members of our Advisory Committee. Criteria were publicized on InterPride's website throughout the application period.

All applicants were required to submit two letters of reference I addition to their online proposal.

Applicants are also required to submit a brief completion report to InterPride within 30 days after completion of the event or project. We will be reporting out on the outcomes of these grants in 2016 once all events have occurred.

Application Results:

Through our online application system, InterPride received the following applications by region:

Total: 37 applications

An initial review of the applications screened out all those who had incomplete applications including those without references.

The final number of applications reviewed by the review committee was 26. The committee was given the task of choosing 8-10 applicants and keeping the total grant amount under \$12,000.

The final recommended number of applicants was 9 with a total grant amount of \$12,000.

Report:

Since my election this past AGM in Pittsburgh, I have continued to reach out and connect with each Member Pride in our Region to offer assistance and support. I have also communicated all updates and important information passed along from InterPride's Leadership to the Region. Locally, Indiana was thrust into the World spotlight due to the Religious Freedom Restoration Act (RFRA) that was pushed through legislation that sought to dismantle any protections the LGBTQ+ Community might have had from discrimination. This very dangerous bill was passed by both houses and signed into law by Governor Mike Pence despite the outcry from the LGBTQ+ Community, business leaders both locally and nationally, as well as many organizations around the World. This bill made its way through local government and led to a negative reaction and view of Indiana as a whole. As the President of Indy Pride and the Regional Director for InterPride I met with local leaders to discuss how to fix this situation. This resulted in an amendment that was eventually signed into law by Governor Pence. Though this amendment prohibits the use of this bill to discriminate against LGBTQ+ persons in the state, there is much more work that needs to be done to include protections for sexual orientation and gender identity statewide. The collaboration efforts both regionally and nationally that went into forcing the amendment of the RFRA were immense and will be long lasting partnerships I hope to continue to foster long into the future.

Keeping the RFRA in the spotlight, and not allowing its discriminatory and damning nature to be swept under the rug, has taken a lot of my focus and time over the last year. The fact that we were able to force an amendment through our collaborative efforts is an amazing success. This is the first time that sexual

orientation and gender identity have received any direct protection from discrimination in Indiana.

Another goal of our Region is to have a regional Conference. I have gathered information and materials from other Regional Conferences in the hopes of relaunching the Region 4 Conference in the near future. This is a major move for us and I look forward to continuing the process of partnering with other Regions for guidance and support. I look forward to discussing this further at the AGM with the rest of our Region.



I am pleased to be able to once again report on the work of Region 6; the geographically smallest region of InterPride, but once again one of the largest in

terms of members and organizational leadership.



Last year at the Annual General Meeting in Pittsburgh, we were honored as one of the regions with significant growth. We are happy to have not only sustained the membership level of the past year but had 3 organizations join us this year – 2 Full Members - Hagerstown Hopes and Garden of Peace Project and one affiliate member that is based in the region, Human Rights Campaign. The Regional Director team has

been diligent in making sure that we keep our membership levels up.

The Region has been very vocal in supporting the rights of our Transgender members of the community. Philly Pride Presents, a longtime member of Region 6 and InterPride raised the awareness to higher levels after a very contentious battle to add a Vice President of Operations — Trans Identified to the InterPride executive committee. While myself and the Regional Director Team disagreed with some of the ways the discussion took place it is without question opened up a greater dialogue in our region and the organization about equal representation for not only Transgender individuals, but how we operate our organization overall. This ongoing conversation has created a minor rift in our region and while I understand both sides, I hope that the leaders of all organizations can work together in the coming year to create more positive change rather than division.



To that end our 2015 Regional Conference, hosted by Queens Lesbian & Gay Pride Committee made Trans Issues and Rights the overall theme and focus in educational programming to much success. We were pleased to be joined by two dynamic out Transwomen speakers, Kim Watson, Executive Director of CKLife in Bronx, New York and Melissa Sklarz, the Board Co-Chair at Empire State Pride Agenda, based out of Albany, New York.

At our 2014 regional conference no organization bid to be the host of the 2016 regional conference. With that happening it fell upon the Regional Director Team to find a host or to put together the conference themselves. Since I am a member of the RD Team, I convinced my home organization, Pride Center of Staten Island to bid in Pittsburgh for the opportunity to host in 2016. While the vote was close, the Pride Center is excited and honored to be hosting the next

regional, March 4-6, 2016. Informa-

tion on the conference can be found at pridecentersi.org/nerp.



Presently there is also no organization chosen to be the host of NERP 2017. It is my hope that some organization steps forward at the AGM instead of waiting until Staten Island in March. This will allow that organization the muchneeded extra time to plan and create and then execute on a successful conference.

This past year I was able to attend a few different Pride events and

represent InterPride. I ran Staten Island PrideFest and attended Queens Pride, Brooklyn Pride, NYC Pride, North Jersey Pride, Rhode Island Pride and Chesapeake Pride Festival's founder, Rev. Dr. Wayne Schwandt's memorial service, after his sudden death earlier this year.

I had been talking with members of Chesapeake Pride Festival about rejoining in 2015 and how they wanted to reinvigorate their event. They decided to put the event on hiatus only days before Wayne's passing, but they promise to be back in 2016 with a new and brighter event, one that will be a loving tribute to Wayne and to reflect his passion, desire and commitment to our LGBT community. I personally would like to use this space to reflect on my interactions with Wayne as one filled with joy, compassion, energy and warmth. I will miss him and on behalf of all of the members of Region 6 send our continued condolences and best wishes to his beloved husband, Chuck Riley and all of their family and friends.

The membership of this region has elected me four times to be part of the Regional Director team, once as Alternate Regional Director (2005-2007), and thrice as Regional Director (2007-2009, 2012-2014 and 2014-Present). I am proud of the work that I have done in this role and look forward to supporting the

region and InterPride in the future after my term is up in March 2016. I thank all of the member organizations and their delegates for the trust and faith that they have put in me. I hope that I have not disappointed them in any way and know that if I ever did it was never with intent. I am honored to be part of this Board of Directors and to be part of the work InterPride does.

REGION 7 (FCP)

Regional Directors: Chrissy Taylor, Brice Field and Dominique Lavergne

Through discussions with our InterPride and Fierté Canada Pride (FCP) colleagues, three topics were identified after the AGM in Pittsburgh to be a focus at the FCP/ Region 7 conference that took place February 19 - 22in Saskatoon, Saskatchewan. We believed that these 3 topics would promote InterPride's vision of a world where there is full cultural, social, and legal equality for all. The topics were Trans* inclusion, consent within the queer community and an introduction to the Two-Spirit community.

Both Friday and Saturday of the conference had dedicated workshops. Friday provided a dedicated workshop titled "Historical and Contemporary Oppressions of Queer and Two-Spirit Peoples in Canada" followed by a First Nations cultural performance at Wanuskewin Heritage Park. Saturday afternoon we were fortunate enough to have three members of the 519 Outreach Centre from Toronto facilitate a dedicated workshop titled "Fostering a Trans* Inclusive Environment". The workshop on Consent was not dedicated, but a first of its kind at a Region 7 conference. The title of the consent workshop was "Alcohol & Sexual Decision Making: Pride's Responsibility."

Our conference saw a major shift in the way the event was organized and delivered. In the past FCP/InterPride had little oversight in the structure and content that was being presented to delegates. To help bridge this gap between the host city and FCP/InterPride the 2015 FCP/InterPride Conference Committee was made up of a collaborative team of stakeholders. The committee consisted of 2 representatives from the host organization (Saskatoon Diversity Network), 2 representatives from Tourism Saskatoon and 2 representatives FCP. Because Brice was a FCP Regional Director and an InterPride RD he was able to represent both Region 7 and FCP on this committee. In past years, 100% of the financial responsibility of hosting the conference would fall on the local Pride. Having the host city take of the financial risk was limiting the number of cities that were able to host the yearly conference. The Conference saw FCP take on the financial responsibility of the conference in hopes that this would allow smaller Prides the opportunity to host the conference in the future. Having this financial structure was key in allowing Saskatoon to host the 2015 conference. This same conference structure is being kept for the 2016 conference, to ensure all Prides, large and small have the opportunity to bid and host a Region 7 Conference. Going forward, a permanent position has been created on the FCP/Region 7 conference planning committee for InterPride representation.

In May of this year, FCP announced the launch of a national campaign #Stand4Trans. The campaign was created to support and raise awareness of trans communities across Canada. The FCP board of directors created this as

their theme for 2015/2016 leading up to the next annual conference being held in London, Ontario in February 2016. "Many trans people are invisible in their communities, isolated, discriminated against and lack the support of family, friends, co-workers, and even healthcare workers. It's time for our trans friends to be visible, welcomed and accepted everywhere," says Wilbur Turner, President of FCP. "This is about human dignity. It is time for hearts and minds to be opened and for inclusion. No one should be denied access to housing, healthcare and jobs because of who they are. Everyone should feel safe to leave their homes and enjoy public spaces regardless of their gender identity." He adds. "The #Stand4Trans Campaign sends an important message to trans people that they are included in Pride celebrations and it sends a message to others inclusion is essential." said Susan Gapka, FCP's Central Region Representative. "If you meet a trans person please let them know they are supported and that they are loved."

Another great campaign that emerged out of Region 7 is the Trans Equality Now (TEN) campaign. As part of the 2015 Vancouver Pride Parade and Festival, the Vancouver Pride Society (VPS) required entries in the 2015 Vancouver Pride Parade to pledge public support for Transgender Equality legislation in Canada. The pledge supports the creation of legislation at both the federal and provincial level to amend current laws to include explicit protection for Gender Identity and Gender Expression. This would extend human rights to Transgender and Gender-Variant Canadians. TEN was intentionally created to be external to VPS so that other prides could join the campaign and together have a larger collective voice. So far Victoria Pride has signed on and Calgary Pride has had similar requirements. The TEN campaign will continue until Transgender and Gender-Variant Canadians are included in the Canadian Human Rights Act and the Criminal Code of Canada. TEN currently has roughly 2500 signatures and is growing as more prides sign onto the initiative. For more information go to transequalitynow.ca.

Throughout the year, Chrissy Taylor, Brice Field and Dominique Lavergne were all able to attend the 2015 FCP/Region 7 Conference in Saskatoon. Chrissy and Brice were able to attend the InterPride mid year meeting, and Brice Field also attended the POSE Conference in Charlotte North Carolina.

There are approximately 60 prides in Region 7, 27 currently active with InterPride. 7 Band new to the InterPride/FCP family this year.

In 2015 FCP scholarship funds were handed out to 9 individuals totaling \$5,000, to attend the FCP/Region 7 conference. Based on the amazing amount of financial support pledge to next year's scholarship fund at this year's

conference, total scholarship funds should exceed the \$5,000 mark for the 2016 conference in London, Ontario.

Two significant motions were passed at this year's AGM. The first was on the creation of a national pride festival to take place in 2017. The second motion was to award the inaugural Fierté Canada Pride Festival to Fierté Montreal. Both motions were unanimously passed at the AGM on February 21. Montreal will host the first ever Fierté Canada Pride Festival over a 2 week period (one week longer than usual for Pride in Montreal). 2017 marks a number of significant milestones Canada with the 375th anniversary of Montreal, the 150th anniversary Confederation and 50 years since Montreal held "Expo 67". Included in the Fierté Canada Pride Festival will be a human rights conference, food fairs, celebration of Canadian culture and so much more.

In conclusion, with the success of the 2015 FCP/Region 7 Conference, the creation of a national Pride Festival, strides towards the Pride movement being Trans* inclusive and new Prides forming across the country; Region 7 had an outstanding year.





REGION 12

Regional Directors: Stefan Baier and Uwe Hörner

Since the last AGM and World Conference, we had two German regional conferences — one in Dresden and one in Mannheim. Again a meeting of the German Prides — the biggest part of Prides in Region 12. As always they, are great for networking and talking about our experiences with our Prides and we are very proud that there is a fixed half-year rhythm now in which the conferences take place.

One of the board members of CSD Deutschland e. V. (the German Prides association) is our new second region 12 director Uwe Hörner. So you can be sure InterPride and the InterPride AGM&WC is mentioned at our regional conferences.

The next regional conference will take place on October 24 in Oldenburg right



we will join this one in person and will tell the attendees all of the news and experiences from Las Vegas. The Austrian and Swiss Prides are invited as well.

We think it is positive for the other Prides, that we keep them up to date what is going on with InterPride, when and where the next AGMs take place, and so on.

On the other side, it is still difficult to bring our Prides in Region 12 to our AGMs and to increase our membership here. The problem is that there are no really big benefits for Non-US-Prides, and the travel costs are expensive.

We hope that we will have more Region 12 prides joining our AGM in Montpellier, France in 2016.

We think by now InterPride is well-known by the Region 12 Prides.

There are 75 Prides (67 in Germany, 5 in Switzerland, 3 in Austria and no Pride in Lichtenstein) in Region 12. – InterPride members are 6 of them: Hamburg, Mannheim, Konstanz, Braunschweig, Vienna and Zurich).

As soon as we notice that there are new Prides in our region we try to get in contact with them, offer them our help and try to visit them at their Pride.

There are three new Prides in Germany since last year: Mönchengladbach, Aurich and Pirna. One Pride organization is not existing anymore: that's Heilbronn

This year Uwe was visiting the following prides: Karlsruhe, Köln, Berlin, München, Hamburg, Frankfurt, Stuttgart, Darmstadt, and of course at his own Pride: Mannheim

Stefan was only able to visit Zurich and was at his own Pride: Konstanz/Kreuzlingen

Uwe was also joining the EPOA AGM this year in Amsterdam, and spoke to the organizers of Europride 2016 - looks like we can have space somewhere on a wall/tower where we can advertise our region 12 prides.

We will talk to Madrid Pride as well if it is possible to do something similar at WorldPride 2017.

REGION 14

Regional Directors: Juan Carlos Alonso Reguero and Andrea Maccarrone

Andrea: As Regional Director of Region 14, I established relations with the Italian Pride Organizations and held in Rome (March 15), the first meeting of Italian Pride Organizers. The meeting was quite a success with the participation of 6 Pride Organizers over 12 (Bologna, Milan, Perugia, Rome, Turin, Verona) plus other LGBTQ+ organizations.

During the meeting, we had a Pride Radar presentation and decided to have a joint Italian Prides communication campaign

that had finally involver all 13 Italian prides 2015 (Pavia pride was fixed after the meeting in Rome).

I also reported to the Co-Presidents about a security alert on Verona Pride raised to InterPride by the United States Secretary of State.

PROMOTION OF THE ASSOCIATION & WORLDPRIDE SPONSOR

Juan Carlos: During the last Madrid International fair of tourism (FITUR) from 28th of January to 1st of February, I made a special promotion from InterPride at the stand AEGAL had in the LGBT area of the fair.

Took part in several meetings and a workshop to Exchange experiences. The objective of these actions, was to promote Madrid Pride, Madrid WorldPride 2017 and InterPride.

Also a special promotional action is taken: two members of the WorldPride team traveled throughout the fair, inviting visitors to take some pictures with some promotional posters from Madrid WorldPride 2017. With this material a photo álbum was shared on the official Facebook of Madrid WorldPride, social networks and on the website: visitchueca.com.

The same action took place during the last edition of the "Regenbogen Ball" in Vienna (31 January of 2015). We also do other promotional actions for the Madrid WorldPride 2017.

All of these promotional events were performed with the collaboration of my team of volunteers and the support of AEGAL.

Since I occupied the position of Regional Director (RD) 14, all printed programs,



brochures, and informative ítems of Madrid Pride, Madrid WorldPride 2017 are displaying the InterPride & EPOA logos following my instructions in order to promote the Associations.

All of these materials were distributed all over Spain territory, certain tourist information corners of Spain in Europe and international fairs of tourism. WorldPride Madrid 2017 has sponsored the selection for Diversity. 106 athletes who participated with great success in the last edition of the Eurogames in Stockholm during the second week of August.

MEETINGS

Nationals

I signed an agreement with Pride Barcelona, with the aim of increasing support for Madrid WorldPride 2017 and to strengthen collaboration between Pride Barcelona & Madrid Pride.

I have had meetings with the new Board of Directors from COGAM (LGBT Association from Madrid) & FELGTB (National Federation LGBT from Spain).

These meetings had two objectives:

Continue to work together and strengthen support of both organizations to Madrid WorldPride 2017

Contact and keep meetings with the 23 Prides registered in Spain.

During the election campaign last may, I also have hold meetings with all candidates for the Madrid City Council and the Regional Government, in order to seek support for Madrid WorldPride 2017.

Once formed the new City Hall and Regional Government, these meetings have become to produce again.

Also I have had many meetings with different companies, with the aim of achieving best private sponsors.

I have had meetings with different Prides in USA, Canadá, Latin América, Israel and especially in Europe.

I participated in the Skype call of InterPride board from November 2014 to September 2015. (Also in the WorldPride Committee).

Different promotional actions from Brazil Prides, focusing this time on 3 cities: Belo Horizonte, Brasilia and Rio de Janeiro.

WORLD AIDS DAY EVENTS

November 30, as every year, HELP (Solidarity Week) in collaboration with COGAM and FELGTB organized the tribute to the AIDS victims in Puerta de Alcalá, Madrid.
